3. Supervising the Board of Management by the Board of Directors

- The BOD held regular quarterly meetings and extraordinary meetings to review and discuss developments in the global and domestic markets affecting the Textile and Garment industry, as well as the industry trends. During these meetings, the BOD reviewed the implementation status of resolutions, evaluated the quarterly and cumulative Production and Business (P&B) results, and deliberated on and approved resolutions for execution by the General Director and the Executive Board.

- Based on the results achieved in 2025, the BOD acknowledged that the General Director and the Executive Board made efforts to overcome difficulties affecting production and business activities, while complying with applicable legal regulations and the Corporation's operating regulations.

- The BOD provided direction to the Executive Board:

+ Proactively implement strategies to diversify markets, customers, and products; and refine and reorganize the management model of units in line with fluctuations in labor, markets, and customers.

Focus on key targets for revenue, profit, growth, and salary policies in order to retain employees.

+ Promote digital transformation, technological innovation, and investment in sustainable development and green transition programs; while managing and reducing costs to enhance production and business efficiency. In 2025, the Corporation completed the green factory investment project at the Garment 10 Corporation – JSC Branch – Thai Ha Garment Enterprise in Gia Le Industrial Park, Hung Yen province; renovated the Corporation's premises to create a green, clean, and beautiful environment for employees; and implemented rooftop solar power projects at factories, thereby contributing to reducing electricity costs and greenhouse gas

emissions. Digital transformation efforts were deployed decisively and synchronously throughout the entire system with numerous effective digital initiatives. Employees proactively applied digital technology in their work, contributing to the establishment of professional, streamlined, transparent, cost-efficient, and well-controlled process.

- The BOD set the goals and long-term vision until 2035 based on three strategic pillars, and established a Strategic Investment Council to develop and implement plans to achieve these goals.

- The BOD directed the Executive Board to successfully organize the 2025 Annual General Meeting of Shareholders and the 80th Anniversary Celebration of the Corporation's establishment.

4. Activities of the Board of Directors' subcommittees

In 2025, the Corporation's Internal Audit Committee carried out its activities in accordance with the annual audit plan approved by the Board of Directors. The Committee focused on reviewing the Corporation's regulatory documents and regulations to ensure compliance with reality and legal provisions. Additionally, the Committee conducted specialized audits in accordance with the plan established at the beginning of the year. Through these audits, the Committee provided recommendations to the Corporation's Executive Board regarding the remediation of shortcomings and deficiencies in the units, thereby contributing to the enhancement of the Corporation's risk management and internal control system.

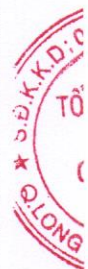

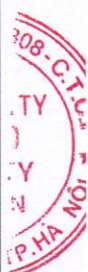


